



ASSOCIATE MEMBERSHIP OF WINE TASMANIA

To join Wine Tasmania as an associate member, you must be eligible under one of the six classes available: brand showcase, corporate, government, employee, student or an individual.

1. **Brand Showcase members (Corporate or Government)** (\$914+GST p.a.) are corporate or government members as listed below, who wish to upgrade their membership to showcase their company brand/logo with a website link in the monthly Wine Tasmania e-newsletter and within the members only section of Wine Tasmania's website. Your details will also be included in Wine Tasmania's information provided in response to any new investment enquiries, as a 'recommended supplier'.
2. **Corporate members** (\$669+GST p.a.) are corporate entities or individuals who do not satisfy the criteria for ordinary membership but who have commercial or other interests in the wine industry, eg. wine distributors, educators, commercial suppliers to the wine sector. Your details will also be included in Wine Tasmania's information provided in response to any new investment enquiries, as a 'recommended supplier'. Where a member is a corporate entity, an individual person must be nominated as the formal representative of that entity. Additional employees, other than the nominated representative, may be nominated as employee members (see below).
3. **Government members** (\$669+GST p.a.) are government and semi-government departments or individuals with interests in the wine sector, eg. Tasmanian Institute of Agriculture, Government Departments. Where a member is a government department, an individual person must be nominated as the formal representative. Additional employees other than the nominated representative may be employee members (see below).
4. **Employee members** (\$27+GST p.a.) are individuals employed by ordinary members, corporate or government members who would like to receive industry communications and information in their own right.
5. **Student members** (\$194+GST pa) are individuals currently studying a minimum of 50% of a full-time student equivalent load in a recognised Australian viticulture, oenology or other relevant course.
6. **Individual / Networking members** (\$194+GST p.a.) are individuals taking out a personal membership wishing to support the wine sector and receive communication and updates, eg. wine consumers, individual trade and media representatives, past wine sector participants.

In addition to the benefits listed in the above categories, you will also receive the following benefits as an associate member:

- A permanent office, CEO and Technical & Extension Officer to professionally represent the sector
- Wine Tasmania's regular e-newsletter
- Access to the 'member only' section and resources on Wine Tasmania's website
- Invitations to a range of workshops and events, with access to member pricing
- The opportunity to sponsor Wine Tasmania member seminars
- Access to the Wine Tasmania logo for use in marketing / corporate materials
- While Associate members do not have voting rights, you are welcome to attend general meetings

Optional Benefits for Brand Showcase and Corporate Members only:

- **Trade display at Wine Tasmania's 2024 Technical Field Day on 16 September** (\$314+GST) - the biggest event on the annual workshop program, the Field Day is attended by 60+ wine producers across the state for a full day of practical presentations. A limited number of trade displays are available, comprising a trestle table for you to display material / banners (machinery display can be accommodated if needed), recognition of your name / logo in the program, presentation, online event listing and event promotion, and one complimentary ticket to the event.
